Complete and pass ISE 201 (Engineering Probability and Statistics) in Fall 2019, not for graduate credit. Complete and pass ISE 140 (Operations Planning and Control) in Fall 2019, not for graduate credit. Complete and pass ISE 230 in Fall 2019, FOR graduate credit. Complete and pass ISE 167 (System Simulation) in Spring 2020, FOR graduate credit (i.e., as part of your 30-unit MS-ISE Program). The passing grade for a graduate student is C. Any violation of these requirements will result in disqualification from the MS-ISE Program, except for clearly proven documentation of extenuating circumstances. You are required to consult with the graduate advisor when any violation of these requirements becomes likely and immediately after such a violation has occurred. Any deviation from the schedule requires prior approval by the graduate advisor. Failure to consult with the graduate advisor after any such violation or any deviation from the schedule without prior approval by the graduate advisor will result in disqualification from the MS-ISE Program.

ISE 201 is a critically important course for the MS-ISE Program; an MS-ISE student is not allowed to enroll in any graduate (200-level) ISE courses (except ISE 230) requiring ISE 130 (Engineering Probability and Statistics) or ISE 201 as a prerequisite until he/she has completed ISE 201 with a grade of B or better. 


